- The State Government reserves the reduced withdraw the above certificate at any time without giving 2. prior notice and without assigning any reason if any deviation of rules reported in future and the management falls to comply with the instructions of the State Government.
- 3. Admission should be made with the bonafide dates of birth certificate.
- The management should collect the juition fee and special fee etc. as prescribed by Fee Regulation 4 Committee appointed by the State Government.
- The strength in classes should be as per rule in force prescribed for English medium schools. 5.
- The management should tollow the State Board syllabus for Classes from 1 to 5th... 6
- 7. The school should follow the three language formula till 8th Standard and Marathi as II language.
- The District Educational Officer or his nominee should be invited when the management makes 8. recruitment of candidates for various categories of posts
- 9 Staff salaries should be paid as per Government Scales of my.
- The management should not collect domain as cherefron the students or from parents.

- No classes should be opened without prior sanction /permission from the Education Officer (Primary and Secondary).

- 20. The State Government reserves the rights to carry out academic /audit inspection of the school. It will be mandatory to the school to provide any information at any time required by the Government.
